## **Minutes**

I. Call Subcommittee Meeting to order Dr. Knapp called the meeting to order at 3:43 pm

III. Public comment regarding items on the agenda

There were no public comments regarding items on the agenda.

IV. Items for action/Discussion

A. Discuss 2016-2017 Curriculum Goals

Dr. Knapp opened the discussion with the question of what the committee should focus on for FY 16/17. Dr. Fortin noted that by end of year the draft of STE curriculum guide will be done. It is being worked on by Dr. Fortin in conjunction with teachers K-12. They will match up the new standards with what is currently being taught. They have noted that the engineering portion has gaps in the curriculum. They are working on standards and requirements per grade. They are also working on the guide to digital literacy/computer science. This will replace tech ed and library media.

Dr. Knapp questioned how will we check outcomes and is that part of the process being looked at. Dr. Fortin noted assessments will be part of that and it will be a continuing process. The committee discussed the anticipated resource needs, which Dr. Fortin noted is also being looked at, especially in the Science department with regard to books in the classroom.

Dr. Fortin noted that the social emotional learning process with Mr. Cameron will be starting mid-year with Health and PE worked on next.

Dr. Knapp brought up teacher evaluations. The committee discussed what may be used as evidence and what part Dr. Fortin plays in this. They discussed DDMs, evaluations and what constitutes a high quality assessment. The committee noted the amount of initiative and lack of time are a limiting factor.

The committee discussed what can show growth and/or measure of growth. What could the committee do to facilitate community planning. Potentially look at other district and what they do.

Dr. Knapp questioned the number of AP classes at the high school and how to increase offerings. Dr. Fortin noted that would need a conversation about staffing needs at the high school. Mr. Charron asked for information regarding what classes are available and what is the supply and demand for those classes. This information will be forthcoming at another meeting.

    The committee will look at this for curriculum goals of the coming year. Check how
    many policies would fall under Curriculum and Instruction and to prioritize them with
    the Personnel & Policy committee.
- C. Review use of data for measuring student achievement and outcomes
  - 1. Quarterly update on progress toward student learning goals Dr. Fortin noted that he will email the members the assessment calendar. Dr. Fortin noted that the kindergarten will no longer be using the TS Gold assessment. He also noted that assessment, K-12, are done three times a year. The committee discussed when to look at data from assessments. The committee will be looking at what assessments are being used currently and what the district is trying to do with it. Dr. Fortin noted this year the district purchased new assessments for grades 4-6 math and 7-8 reading and math. The committee will meet in November to see what assessment are being used.

## V. Unfinished Business

A. Update on school data dashboards creation

Dr. Fortin noted that at the end of last year the general response was it would be a good idea. The committee discussed how and what data would be useful. Dr. Knapp agreed to look at what dashboards may be useful for this district.

It was noted the next meeting will work on curriculum goals for next year and the next C&I meeting will be September 27 at 6:00 pm.
